**RESOLUTION
2009-69**

**A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS
OF LEVY COUNTY, FLORIDA EXPRESSING SUPPORT FOR
ADOPTION BY CONGRESS OF THE "FAIR TAX."**

WHEREAS, every American business and individual is directly affected by the income tax system; and

WHEREAS, the federal tax system should raise needed revenue for the common good in a manner that is both fair to all and without distortions of business and personal financial decisions; and

WHEREAS, the current income tax system is so complex that obeying tax laws requires business and individual costs in the hundreds of billions of dollars annually; and

WHEREAS, the current income tax system is beyond repair and should be replaced with the Fair Tax; and

WHEREAS, the Fair Tax would be beneficial to both the local and national economy.

NOW, THEREFORE, BE IT RESOLVED that the Board of County Commissioners of Levy County, Florida supports the complete replacement of the current tax system with the Fair Tax and urges Congress to enact the Fair Tax into law.

BE IT FURTHER RESOLVED that the Board strongly urges the 111th Congress of the United States to enact Fair Tax reform legislation without delay.

AND, BE IT FURTHER RESOLVED that the Clerk of Court to the to the Board of County Commissioners is hereby directed to forward a copy of this resolution to the 111th Congress of the United States and the federal legislative delegation.
